- (ii) to collect royalties and/or other payments past, current, and future relating to the Patent Rights; and
- (iii) to apply for patents, certificates of invention or other governmental grants for the Patent Rights, including without limitation under any convention, treaty, agreement or understanding.


Assignor also hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents or certificates of invention which may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.
