**ASSIGNMENT**


WHEREAS, Roland Curtains USA, Inc., a corporation of the State of Delaware, having a postal address of 3212 Pinewood Drive, Arlington, Texas 76010, is the owner of U.S. Patent No. 7,578,539, issued August 25, 2009, entitled APPARATUS FOR DECREASING OPENING VELOCITIES OF SUPPORT PILLARS, as shown by Assignment recorded on Reel 020982 and Frame 0671 as of May 22, 2008; and

WHEREAS, Roland Curtains, Inc., a Delaware corporation, having a postal address of 3212 Pinewood Drive, Arlington, Texas 76010, is desirous of acquiring the entire right, title and interest in and to said invention and any and all Letters Patent of the United States and Letters Patent in any and all foreign countries which may be or have been obtained therefor;

Pursuant to this APA, Roland Curtains USA Inc. agreed to assign the above mentioned Patent, through the signing of a Patent Assignment, effective as of January 1, 2010, a copy of which is attached to the APA.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, they do hereby sell, assign, transfer and set over unto the said Roland Curtains, Inc., its legal representatives, successors and assigns, the entire right, title and interest in and to said invention, as described in the above mentioned Patent, and in and to all patents of the United States and in any and all foreign countries which may be issued for said invention, and in and to all patent applications, continuations, continuations-in-part, divisionals, reexaminations and reissues of said invention as described in the above-mentioned Patent in the United States and in any and all foreign countries, as fully and completely as the same would have been held by it had this Assignment and sale not been made, together with all claims for damages by reason of past infringement with the right to sue for and collect the same and obtain all other possible remedies for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives. The said entire right, title and interest shall vest irrevocably in said Roland Curtains, Inc. They further agree upon request, without additional compensation but at no expense to itself, to execute or assent to foreign applications, and to execute all other legal documents as may be necessary or desirable to vest the enjoyment of the said entire right, title and interest hereby transferred in Roland Curtains, Inc., its legal representatives, successors and assigns, or as the said company may direct.
