ASSIGNMENT AGREEMENT

Eagle represents and warrants that it is the owner of the interest herein assigned, that Eagle has the right to make this Assignment, that the undersigned has the authority to bind Eagle and act on Eagle's behalf, and that there are no outstanding prior assignments except to NABPF, licenses or other rights in the interest herein assigned.
3. The terms and covenants of this Assignment shall inure to the benefit of the NABPF, its successors and assigns and other legal representatives, and shall be binding upon Eagle, its successors, legal representatives and assigns.

Eagle executes this valid and binding assignment as of the Effective Date.

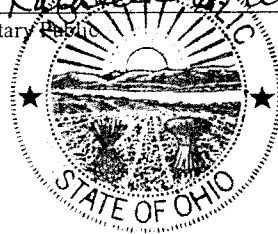
