ASSIGNMENT

WHEREAS we,
Nicolaas DEKKER, (the "Inventor"), residing at Jadelaan 37, 3162 PA Rhoon, the Netherlands, a citizen of the Netherlands, and

Hervé Lepetit, 15 Rue Jules Trefousse, 52000 Chaumont, France, a citizen of France,

are the inventors of *Blinds for windows*, for which invention design applications were filed at the OHIM (Office for Harmonization in the Internal Market, hereinafter called "the European design") with serial numbers **001317630-0001** and **001317630-0002** on 8 March 2012 and we are entitled to assign our entire right, title and interest world-wide in and to the invention and any intellectual property protection for the invention, including the European design application therefor; and

FURTHER we hereby authorize and request any official of any state, responsible for issuing designs or other evidence or forms of any industrial property protection, to issue the same for the invention to the Company, its successors, legal representatives and assigns, in accordance with this assignment.

ALSO we hereby agree that we have the full right to convey our entire, right, title and interest in and to the invention world-wide and all applications for industrial property protection for the invention world-wide and that we have not executed, and will not execute, any agreement in conflict with this assignment.

MOREOVER we hereby agree that we will communicate to the Company, its successors, legal representatives and assigns any facts known to me respecting the invention and testify in any legal proceeding, sign any lawful papers, execute any original, divisional, continuation and reissue applications, make any rightful oaths, and generally do everything possible to aid the Company, its successors, legal representatives and assigns to obtain and enforce proper protection for the invention world-wide.

FURTHER we hereby agree that this assignment is to be considered effective as of the filing date of the European design application.




