WHEREAS, I have invented certain inventions and improvements disclosed in a utility patent application entitled "External Antenna Detection Device," the specification of which is attached hereto.

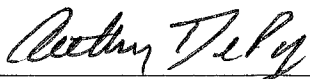
For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, the undersigned inventor, hereby:
