RELEASE OF PATENTS

THIS RELEASE OF PATENTS is dated as of November 1, 2012 by General Electric Capital Corporation, as Agent ("Agent").



Agent further agrees, at the sole cost and expense of Grantor, to perform all acts reasonably requested by Grantor to effect the release and termination of its security interests and liens in the Patent Collateral.
