AND, for the same consideration, ASSIGNOR hereby covenants that he will promptly provide ASSIGNEE, upon its request, with all pertinent facts and documents relating to the patent, the invention and the application for Letters Patent as may be known and accessible to ASSIGNOR, and that ASSIGNOR will testify as the same in any interference or litigation related thereto, including past infringement related to the patent, and that ASSIGNOR will take all lawful oaths and acts necessary and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain and enforce the invention and above-mentioned application, and any Letters Patent for

said invention in any country, which may be necessary or desirable to carry out the purposes thereof.
