TRANSFER OF INTELLECTUAL PROPERTY RIGHTS

Between

"ALBIS INTERNATIONAL S R. L."

a sole shareholder company, with Registered Office in Milan, Via Leopardi no. 8 registration number in the Milan Company Register and Tax Code 06982960962, share capital of euro 1,300,000, represented by the Chairman of the Board of Directors, Ms. Cristina BOSCOLO, born on 24 September 1968 in Biella, domiciled for the office in Milan, Via Leopardi no. 6, vested with the necessary powers on the basis of resolution of the Board of Directors of 26 May 2010;

"ALBIS S.P.A."

with Registered Office in Milan, Via Nirone No. 8 registration number in the Milan Company Register and Tax Code 01812340022, share capital of euro 312,000, represented by its Sole Director, Mr. Galliano said Gianni, Boscolo, born in Quarto d'Altino (VE) on 25 August 1941, domiciled for the office in Milan, Via Nirone no. 8, as sole director, who is vested with the broadest powers of administration in accordance with the articles of association;

Whereas:

As part of its restructuring, ALBIS S.P.A. has transferred to ALBIS INTERNATIONAL S.R.L. all its "non-woven fabric" production and marketing operations, as it results from the deed drawn up by notary Paolo Lovisetti Index No 297528/49126 dated 19.05.2010 (hereinafter: the business contribution agreement), recorded at the Revenue Agency -Milan 5 - on 26 May 2010 with no.10948 1T Series, including property, plant and all tangible and intangible assets constituting the business unit.

In this deed reference is made to the clauses of the business contribution agreement relating to the subject matter hereto:

"2) ... the business operations contributed include all the assets and liabilities resulting from the expert surveys annexed hereto under "B" and "C", whose list is intended as a non-exhaustive description, given the will of the parties to transfer to the transferee ALBIS INTERNATIONAL S.R.L. the ownership of all tangible and intangible assets that make up the business unit, as it is currently owned and enjoyed by the transferor company for the purposes of carrying out the described activities";

"5) The transferor company ALBIS S.P.A. undertakes to carry out any activity that may be required to execute any transfer of title, registration of transfer, recording, registration, change, entry in relation with this deed as well as to sign any document in order to execute the transfer, waving any and all rights on the licences, administrative authorizations, trademarks and patents of the business unit concerned and undertaking as of now to carry out all the formalities that may be required for the regular transfer and registration of those rights in the name of ALBIS INTERNATIONAL S.R.L. "

now therefore

In order to define the transfer of the above mentioned intellectual property rights and draw up a separate deed necessary for the enforcement of such rights and their registration

it is hereby represented and agreed as follows:

Article 1 Transfer of intellectual property rights

(1) ALBIS S.P.A. represents that it has exclusive rights over the intellectual property rights described in Annex 1 to this deed, and that it is entitled to transfer them to ALBIS INTERNATIONAL S.R.L. , and that there are no third parties who may claim any rights or make any claims of any kind whatsoever in relation with such Intellectual Property rights. ALBIS S.P.A. further represents that it is a co-owner of the intellectual property rights described in Annex No. 2 to this deed and that it is entitled to transfer such joint ownership right to ALBIS INTERNATIONAL S.R.L. and that there are no third parties who may claim any rights or make any claims of any kind whatsoever in relation with such Intellectual Property rights, except for the persons mentioned in annex 2.

(2) ALBIS S.P.A. confirms that it has transferred the Intellectual Property rights mentioned in Annex No.1 as well as the joint ownership of the intellectual property rights referred to in Annex no.2, to ALBIS INTERNATIONAL S.R.L, as part of the business contribution agreement, and it actually transfers such rights in its quality respectively as owner and joint owner with effect from 19 May 2010 to ALBIS INTERNATIONAL S.R.L; the latter, where acceptance is required by national law, hereby confirms acceptance of, and it actually accepts, such rights without limitation, including any and all rights related thereto.

Article 2 Purchase consideration

The purchase consideration has already been paid, as it results from the deed of transfer mentioned in the recitals. ALBIS S.P.A. and ALBIS INTERNATIONAL S.R.L. hereby mutually declare that they have no claim whatsoever to make to the other party.

Article 3 Authorization of registration

ALBIS S.P.A., hereby consents, for all intents and purposes, to the registration of the Intellectual Property rights with the Patent and Trademark Offices.

Article 4 Exercise of the rights until registration, damages

ALBIS S.P.A. hereby authorizes ALBIS INTERNATIONAL S.R.L., where an authorization is required according to national law, to enforce, in Italy and in any other country, as substitute party, even before registration of the intellectual property rights, any claim for infringement of such intellectual property rights both in its own name and on behalf of ALBIS S.P.A. All claims for damages for infringements that occurred in the past and until registration are transferred to ALBIS INTERNATIONAL S.R.L..

Article 5 Acceptance

ALBIS SPA accepts all the effects of this deed with respect to all the rights transferred and of which it has ceased to be the owner.
