**PATENT ASSIGNMENT**

In consideration for Buyer's obligation under the Assignment Agreement and for other good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Seller does hereby assign, transfer, grant, sell and otherwise convey to Buyer all of Seller's right, title and interest in and to the Patents, including all common law rights therein, applications to register therefor, together with the good will of the business symbolized by the Patents and all claims for damages by reason of past infringements of the Patents with the right to sue for and collect the same for its own use and benefit, and for the use and on behalf of its successors, assigns and other legal representatives. Seller authorizes the Commissioner of Patents and Trademarks of the United States of America, and the empowered officials of all other governments to issue or transfer all said patents and patent applications to Buyer, as assignee thereof, or otherwise as Buyer may direct.

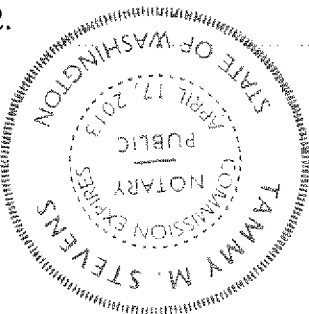
