GRANT OF  
SECURITY INTEREST IN PATENT RIGHTS

This GRANT OF SECURITY INTEREST IN PATENT RIGHTS ("Agreement"), effective as of September 7, 2012 is made by KETERA SOFTWARE INDIA PRIVATE LIMITED, an Indian corporation located at Level 8, Prestige Obelisk, No 3, Kasturba Road, Bangalore 560001, India (the "Borrower"), in favor of LABMORGAN INVESTMENT CORPORATION, a Delaware corporation, as security agent (the "Security Agent") for the Lenders parties to the Term Loan and Security Agreement, dated as of May 25, 2012 by and among Borrower, Rearden Commerce, Inc. a California corporation, Rearden Acquisition Corporation, a Delaware corporation, Global Ground Automation, Inc., a Delaware corporation, Ketera Technologies, Inc., a Delaware corporation, Expensewire, LLC, a Ohio limited liability company, Deem Offers, Inc., a Delaware corporation, and the Lenders (as amended, supplemented or otherwise modified from time to time, the "Term Loan and Security Agreement").

W I T N E S S E T H:

WHEREAS, pursuant to the Term Loan and Security Agreement, the Lenders have agreed to make Loans and certain financial accommodations for the direct or indirect benefit of the Borrower upon the terms and subject to the conditions set forth therein; and

WHEREAS, pursuant to the Term Loan and Security Agreement, the Borrower pledged and granted to the Lenders a first priority, continuing security interest in all Intellectual Property, including the Patents; and

WHEREAS, the Borrower has duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to make Loans and other financial accommodations to the Borrower pursuant to the Term Loan and Security Agreement, the Borrower agrees, for the benefit of the Lenders, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Term Loan and Security Agreement.

SECTION 2. Grant of Security Interest. The Borrower hereby pledges and grants a first priority, continuing security interest in and Lien upon all of the Borrower's right, title and interest in, to and under the Patents (including, without limitation, those items listed on Schedule A hereto) (collectively, the "Collateral") to the Security Agent for the benefit of the Lenders to secure payment, performance and observance of Borrower's Secured Obligations.

SECTION 3. Purpose. This Agreement has been executed and delivered by the Borrower for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Security Agent for the benefit of the Lenders in connection with the Term Loan and Security Agreement and is expressly subject to the terms and conditions thereof. The Term Loan and


Security Agreement (and all rights and remedies of the Lenders thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgment. The Borrower does hereby further acknowledge and affirm that the rights and remedies of the Security Agent with respect to the security interest in the Collateral granted hereby are more fully set forth in the Term Loan and Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the terms of the Term Loan and Security Agreement, the terms of the Term Loan and Security Agreement shall govern.

SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

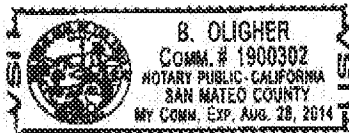
