- (v) the **Community Design**;
- (vi) all copyright and unregistered design right in the **Designs**; and
- (vii) all right to sue for and collect damages resulting from past, present and future infringement of all registered designs, design patents and similar intellectual

property rights which may be granted in respect of the Designs, the Community Design, and copyright and unregistered design rights in the Designs. .
