## ASSIGNMENT

WHEREAS, I, Wilfried Vollmar, of An der Schlenke 14, 59494 Soest, Country of Federal Republic of Germany; has made new and useful improvements in **APPARATUS AND METHOD FOR SUPPLYING ELECTRIC POWER TO A CVD-REACTOR**; for which application for Letters Patent of the United States has been filed on October 5, 2012 under Serial No. 13/639,534; and
