ASSIGNMENT

WHEREAS, we, Bernard Guering, of Montrabe, France, and Yves Durand, of Aussonne, France, hereinafter ("Assignors"), have invented certain new and useful improvements in METHOD OF INTEGRATING AN AVIONICS BAY AND FLOOR STRUCTURE FOR IMPLEMENTATION for which application for a U.S. Patent was made on September 28, 2012 as U.S. Patent Application No. 13/630,877, and which claims priority to French Patent Application No. 11 58843 filed September 30, 2011.


