TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

TERMINATION AND RELEASE (this "Termination and Release") dated as of November 1, 2012 by **BNP PARIBAS**, as administrative agent for and representative of the Beneficiaries (in such capacity, the "Agent"), in favor of **VELCON FILTERS, LLC**, a Delaware limited liability company (the "Obligor").

WITNESSETH:

WHEREAS, pursuant to that certain Second Amended and Restated Security Agreement, dated as of April 30, 2012, made by and among the Agent, the Obligor, and the other grantors named therein (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), the Obligor granted to the Agent, for the ratable benefit of the Lenders, a security interest (the "Security Interest") in certain collateral, including the Patent Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was entered into in connection with that certain Second Amended and Restated Credit Agreement, dated as April 30, 2012, made by and among the Agent, the Obligor and the Lenders;

WHEREAS, in connection with the Security Agreement, the Obligor executed that certain Grant of Patent Security Interest, dated as of April 30, 2012, in favor of the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Patent Security Agreement") for recording with the United States Patent and Trademark Office and any other appropriate governmental authorities;

WHEREAS, the Patent Security Agreement was recorded in the United States Patent and Trademark Office on July 10, 2012 at Reel 028541/Frame 0395;

WHEREAS, the Obligor has requested that the Agent: (a) terminate and release all liens and interests of the Agent in the Patent Collateral and (b) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office; and

WHEREAS, the Obligor has satisfied and fulfilled all of its obligations to release the Agent's Security Interest in the Patent Collateral, and the parties seek to make record of the Agent's release to the Obligor of any and all of its Security Interest in the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. <u>Definitions</u>. All capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Security Agreement. The term "Patent Collateral," as used herein, shall mean all of the Obligor's right, title and interest in and to the following:

- (a) all patent and patent applications issued or applied for and rights and interests in patents and patent applications under any domestic or foreign law (including, without limitation, the patents and patent applications set forth on Schedule A annexed hereto, including all rights to sue for past, present and future infringements thereof and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part of any patents or patent applications (the "Patents"); and
- (b) all proceeds thereof (such as, by way of example and not by limitation, license royalties and proceeds of infringement suits).
- 2. <u>Release of Security Interest</u>. The Agent hereby terminates, discharges and releases to the Obligor the Security Interest in the Patent Collateral, and any right, title or interest of the Agent in such Patent Collateral shall hereby cease and become void.
- 3. <u>Further Assurances</u>. The Agent hereby agrees to duly execute, acknowledge, procure and deliver, at the sole expense of the Obligor or its successors and assigns, any further documents and to do such other acts as may be reasonably necessary to effect the termination, release, discharge or reassignment to the Obligor of the Security Interest contemplated hereby.
- 4. <u>Governing Law</u>. This Termination and Release shall be governed by, and construed in accordance with, the laws of the State of New York.
