This duplicate of the original contract deed has been produced on January 14, 2008.

The parties agree on the following:

1. Assignment of Intellectual Property Rights

The Assignor hereby assigns to the Assignee, and the Assignee accepts the assignment from the Assignor, the following assets (the "Assets"):

- 1.1 the registered intellectual property rights (trademarks, patents, copyrights etc.) and applications therefore as listed in Schedule 1.1. For this purpose, the Assignor will execute the declarations of assignment as per Schedules 1.1(i) to 1.1(iii) and shall execute and deliver upon first demand and at its own expense all and any further declarations which are necessary for the registration of the assignment of the intangible assets listed in Schedule 1.1.
- 1.2 Any and all not and/or not yet registered intellectual and industrial property rights owned by the Assignor (except those referred to in section 1.1 and above) relating to the assets contributed and assigned by Infor International Limited ("Cayman 3") to Assignor pursuant to the Contribution in Kind Agreement dated April 7, 2005 (such assets having been formerly purchased by Cayman 3 from Lilly Software Associates, Inc. and its subsidiaries pursuant to the Asset Purchase Agreement dated October 19, 2004 and the assets purchased by Cayman 3 from Finmatica Limited pursuant to the Administration Assets Sale Agreement dated January 4, 2005) under the laws of any jurisdiction, including, without limitation, under patent law, copyright law, personality rights, design rights, trade secret law, database rights law, know-how, and trademark and trade name law, and any and all goodwill associated therewith, and all rights to apply for registration and patent rights.

2. Consideration

For the assignment of the Assets the Assignee therefore offers the Assignor a note dated October 4, 2007, in the amount of EUR€57,409,219 (the "Consideration"), which is based on the valuation report from Duff & Phelps dated October 3, 2007, and of which €42,172,953 is attributable to the Assets related to the Assignor's Visual business, €6,375,976 is attributable to the Assets related to the Assignor's Demand Planning business, and €8,860,290 is attributable to the Assets related to the Assignor's Optiva business.

3. Representations and Warranties

In reference to the Assets to be sold, the Assignor represents and warrants as follows:

- (a) it is the owner of all rights, titles and interests in and to each of the Assets;
- (b) any applicable fees due in respect of the Asset have been paid;
- (c) it has not licensed the Assets nor has it granted to any other person any other permissions or rights in respect of any of the rights hereby assigned;
- (d) so far as it is aware the Assets are valid, subsisting and enforceable and they are free and clear of all encumbrances, mortgages, charges, liens, security interest or

- any other right of any third party;
- (e) so far as it is aware none of the rights hereby assigned infringe any rights of, or are being infringed by, any third party; and
- (f) it has not waived, or abandoned any of its rights in the Assets nor has it acquiesced in the authorisation use of the same or done or omitted to do any act or thing which may limit any of the rights hereby assigned.

4. General Provisions

- 4.1 This Agreement and the Schedules thereto may be executed in any number of counterparts, each of which shall constitute an original and all of which taken together shall constitute one and the same instrument.
- 4.2 This agreement, including the jurisdiction clause, shall be governed by, interpreted and construed in accordance with the material laws of Switzerland.
- 4.3 The competent courts of the Canton of Schaffhausen, Switzerland, shall have exclusive jurisdiction for all disputes arising out of or in connection with this agreement (including but not limited to matters of validity, conclusion, binding effect, interpretation, construction, performance or non-performance), subject to appeal, if any.




