ASSIGNMENT

WE, Michael Jürs of Schollenstieg 3, 23683 Haffkrug, Germany; and Matthias Schroeder of Dorfstraße 49, 23619 Badendorf, Germany, have invented a method and apparatus entitled **Apparatus and Method for Filleting Beheaded and Eviscerated Fish** hereinafter called the "invention."



Cooperation to the best of our abilities in the execution of all lawful documents, the production of evidence, nullification, reissue, extension or infringement proceedings involving said invention.


