have invented a new and useful process, machine, manufacture, composition of matter, or an improvement thereof, entitled:

**APPARATUS AND METHODS FOR UNFREEZING VEHICLE DOOR
WINDOW FROM WINDOW SEAL**

for which we have executed an application for Letters Patent of the United States on 11-9-12 & 11-13-12.
