WHEREAS I, **FRANZ J. LAIMBOECK**, an Austrian citizen residing at Goleta, California, have invented certain new and useful improvements in a


ENGINE AND CYLINDER WITH GAS EXCHANGE THROUGH THE CYLINDER WALL


