Pursuant to Section 242 of the General
Corporation Law of the State of Delaware

Acambis Inc. (hereinafter called the "Corporation"), a corporation existing under and by virtue of the General Corporation Law of the State of Delaware (the "Delaware Law"), does hereby certify that (a) by a Unanimous Written Consent of Directors dated December 2, 2008, the Board of Directors duly adopted resolutions pursuant to Section 242 of the Delaware Law proposing a certain amendment to the Third Amended and Restated Certificate of Incorporation of the Corporation and declaring said amendment to be advisable; and (b) that in lieu of a meeting and vote of the stockholders, the sole stockholder of the Corporation has given its written consent to said amendment in accordance with the provisions of Section 228 of the Delaware Law.

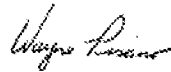
Pursuant to the foregoing resolutions:
