ASSIGNMENT

WHEREAS, We, James Kennedy, residing at 212 Emerson Drive, Zelienople, Butler County, Pennsylvania 16063; and Jon Kaufman, residing at 525 Neville Road, Beaver, Beaver County, Pennsylvania 15009, have invented certain new and useful apparatus, inventions, discoveries and/or improvements disclosed in an application for United States Letters Patent entitled "Center Bowl Liner With Spring Washer Conductor", filed on September 23, 2009 and issued Serial No. 12/564,992, as well as in an application filed under the Patent Cooperation Treaty entitled "Center Bowl Liner With Spring Washer Conductor", filed on September 23, 2009 and issued Serial No. PCT/US09/057981.

The Commissioner of Patents and Trademark is requested to issue any such Letters Patent in accordance herewith. We covenant that we are the lawful owners of the said applications, apparatus, inventions, discoveries and improvements, that the same are unencumbered, that no license has been granted to make, use, or vend the said applications, apparatus, inventions, discoveries or improvements or any of them, and that we have the full right to make this Assignment.

And for said consideration, we agree, jointly and individually, that we will communicate to said Assignee or the representatives thereof any facts known to us respecting said apparatus, inventions, discoveries and improvements, and will, upon request, but without expense to us, testify in any legal proceedings, sign all lawful papers, execute all divisional, reissue, continuation, continuation-in-part, renewal and/or extension applications, make all rightful oaths,

and generally do all other and further lawful acts, deemed necessary or expedient by said Assignee or by counsel for said Assignee, to assist or enable said Assignee to obtain and enforce full benefits from the rights and interests herein assigned, and, in the event of any application or Letters Patent assigned herein becoming involved in an Interference, to cooperate to the best of the ability of the undersigned in the matters of preparing and executing the preliminary statement and giving and producing evidence in support thereof. This Assignment shall be binding upon our heirs, executors, administrators and/or assigns, and shall inure to the benefit of the heirs, executors, administrators, successors and/or assigns, as the case may be, of said Assignee.

And for said consideration, the undersigned hereby agrees to execute, at the request of said Assignee, all documents in connection with any application for foreign letters patent therefore.
