## ASSIGNMENT

WHEREAS, Juergen H Lohrke of Grand Rapids, Michigan, Herbert K Lohrke of St. Joseph, Michigan, and Joseph L Naimo of Grand Rapids, Michigan (hereinafter referred to as Assignor) have invented and own certain new and useful improvements in GROCERY BAG STAND for which an application for United States Letters Patent was executed on even date herewith.

Assignor agrees to communicate to said Assignee or its representatives any facts known to Assignor respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuation-in-part, substitution, renewal, and reissue applications, to execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Assignee, to make all rightful oaths and to generally make reasonable business effort to aid said Assignee to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
