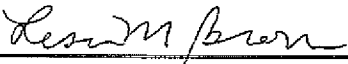

I acknowledge my prior and ongoing obligations to sell, assign, and transfer my rights under this

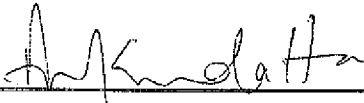
