AND I HEREBY COVENANT AND AGREE that I will execute or procure any further necessary assurance of title to said invention and any Letters Patent which may issue therefor and that I will, at any time, upon the request and at the expense of **ASSIGNEE** deliver any testimony in any legal proceedings and execute all papers that may be necessary or desirable to perfect the title to said invention or any Letters Patent

which may be granted therefor in **ASSIGNEE**, its successors, assigns, or other legal representatives, and that I will, at any time, upon the request and at the expense of **ASSIGNEE** execute any continuations, divisions, reissues, or any other additional applications for Letters Patent for said invention or any part or parts thereof, all of which applications and any Letters Patent issuing thereon are hereby assigned to **ASSIGNEE**, and will make all rightful oaths, and do all lawful acts requisite for procuring the same therein, without further compensation, but at the expense of **ASSIGNEE**, its successors, assigns or other legal representatives.


