## RELEASE OF PATENT SECURITY INTEREST

**THIS RELEASE OF PATENT SECURITY INTEREST** (“Release”) is executed as of October 26, 2012, by Banc of America Securities Limited, as security agent for the Secured Parties (the “Security Agent”), for the benefit of FCI Automotive USA, Inc. (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the meaning assigned to such terms in the Security Agreement (as defined below).

**WHEREAS**, pursuant to the (i) Security Agreement dated as of September 8, 2011 (the “Security Agreement”), between the Grantor and the Security Agent, and (ii) Patent Security Agreement, dated as of November 29, 2011 (the “Patent Security Agreement”), between the Grantor and the Security Agent, which Patent Security Agreement was recorded in the U.S. Patent and Trademark Office (the “Office”) on November 30, 2011 at Reel 027298/Frame 0833, the Grantor has granted a security interest to the Security Agent in all of the following property: (a) the United States patents and patent applications as referred to in Schedule A attached hereto; (b) all reissues, divisions, continuations, continuations-in-part, reexaminations and substitutes of any of the items described in clause (a); (c) all rights associated with the foregoing, including the right to sue or otherwise recover for any past, present or future infringement or other violation thereof, and for breach or enforcement of any patent license with respect thereto and all rights corresponding thereto; and (d) all proceeds thereof, including, without limitation, license fees, royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect thereto (the “Patent Collateral”); and

**WHEREAS**, in connection with the discharge of all liabilities and obligations and pursuant to Section 4 of the Patent Security Agreement, the Secured Parties have agreed to release the security interests created under the Patent Security Agreement on the terms and conditions set forth in that certain Global Deed of Release, dated as of September 28, 2012, between, inter alios, the Security Agent and FCI International S.A.S., as the Company and the Obligor’s Agent.

**NOW, THEREFORE**, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby releases the security interests over the Patent Collateral and relinquishes onto the Grantor all right, title and interest in and to the Patent Collateral as of the date first written above.

This Release shall be limited precisely as written and relates and applies solely to the Patent Collateral and the associated interests specifically described above.
