Clock Spring Company L. P. ("Clock Spring"), a Delaware corporation, with its principal place of business located at 114107 Interdrive West, Houston, TX 77032, U.S.A., intends to ensure that Coastal Research Corporation ("Coastal"), located at 114107 Interdrive West, Houston, TX 77032, U.S.A., owns all intellectual property that Clock Spring currently owns or uses in connection with U.S. Patent No. 7,557,570 ("the '570 patent") and a pending patent application in the European Patent Office, No. EP06846220.9-1240/1952135 ("the '135 application"). Clock Spring owns the full and exclusive right, title, and interest in and to the '570 patent, and the '135 European patent application, and the inventions described therein.

Now therefore, for and in consideration of the sum of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Clock Spring sells, assigns, and transfers to Coastal, its successors, assigns, and legal representatives, the entire, worldwide, right, title, and interest in and to the Patents, inventions under the Patents, and all patents which may be granted therefor, and all divisions, reissues, reexaminations, renewals, substitutions, continuations, and extensions thereof, including the right to sue for and collect damages for past infringement of the Patents. Clock Spring authorizes and requests the Commissioner of Patents and Trademarks of the U.S. Patent and Trademark Office and any official of any other country or countries, whose duty it is to issue patents on applications as aforesaid, to issue all patents for the inventions, or patents resulting therefrom, to Coastal.

Clock Spring covenants that Clock Spring has full right to convey the entire interest herein assigned, and that Clock Spring has not executed, and will not execute, any agreement in conflict with this assignment.

Clock Spring further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith, necessary or desirable in the opinion of Coastal or Purchaser, its successors, assigns, and legal representatives, to perfect such rights, title, and interest in Coastal, its successors, assigns, and legal representatives.

Clock Spring will communicate to Coastal, or to its successors, assigns, and legal representatives, any facts known to Clock Spring respecting any improvements regarding the Patents. At the expense of Coastal, Clock Spring shall testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, reexamination, and substitute applications, make all lawful oaths, and generally do everything possible to vest title in the Patents in Coastal. Clock Spring shall aid Coastal, its successors, assigns, and legal representatives, to obtain and enforce proper protection for these Patents and related inventions in all countries.

Clock Spring irrevocably constitutes and appoints Coastal and any officer thereof, with full power of substitution, as Clock Spring's true and lawful attorney-in-fact, with full irrevocable power and authority in Coastal's own name, to take any and all action and to execute thereafter any and all documents and instruments which Coastal deems necessary or desirable to accomplish the purposes of this Assignment. Without limiting the generality of the foregoing, Clock Spring gives Coastal the power and right on its behalf and in its own name to execute any and all applications, assignments, declarations, affidavits, and any other papers in connection therewith deemed necessary or desirable to perfect the assigned rights, title, and interest in Coastal, its successors, assigns, and legal representatives, or to vest title in Coastal, and to aid Coastal, its successors, assigns, and legal representatives to obtain and enforce proper protection for the assigned inventions in all countries, without either notice to Clock Spring or the consent of Clock Spring.

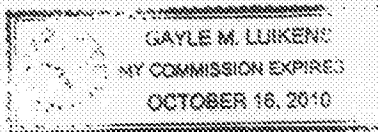
