WHEREAS, Harvey E. Svetlik is desirous of making this patent assignment, and, GWM Products, LLC is willing to receive such patent assignment;

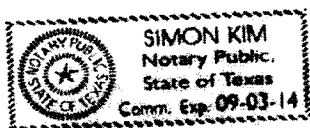
