TERMINATION AND RELEASE OF PATENT SECURITY INTEREST

THIS TERMINATION AND RELEASE OF PATENT SECURITY INTEREST (this "Termination"), is dated as of December 3, 2012, and made by Wilmington Trust, National Association (as successor by merger to Wilmington Trust FSB, "Wilmington Trust") to Newport Television LLC, Newport Television Holdings LLC and Newport Television License LLC (each a "Grantor").

WHEREAS, certain security interests (the "Interests") were granted by the Grantors to Wachovia Bank, National Association ("Wachovia"), in its capacity as collateral agent in respect of certain financing arrangements with the Grantors, in certain collateral, including the Patent (as hereinafter defined);

WHEREAS, the Interests were recorded in the Assignment Division of the United States Patent and Trademark Office on April 16, 2008, at Reel 020808 and Frame 0649;

WHEREAS, pursuant to that certain Collateral Assumption Agreement, dated as of December 16, 2009 (the "Collateral Assumption Agreement"), Wachovia assigned the Interests to Wilmington Trust;

WHEREAS, the Collateral Assumption Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on December 21, 2009, at Reel 023679 and Frame 0466;

WHEREAS, Wilmington Trust now desires to terminate and release the Interests; and

NOW, THEREFORE, for good and valuable consideration, Wilmington Trust hereby states as follows:


1. Definitions. The term "Patent", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the patent listed on Schedule A hereto.

2. Release of Security Interest. Wilmington Trust hereby terminates the Interests and terminates, releases and discharges its interest in the Patent, including any interest created or evidenced by the recordation of the Collateral Assumption Agreement.
