

ARTICLES OF INCORPORATION

OF

The following Restated Articles of Incorporation duly adopted pursuant to the authority and provisions of the Wisconsin Business Corporation Law, Chapter 180 of the Wisconsin Statutes (the "WBCL") supersede and take the place of the existing articles of incorporation of Kelley Company, Inc. (the "Corporation") and any amendments thereto:

- 1. The present name of the Corporation is Kelley Company, Inc.
- 2. Article 1, Section 1 of the articles of incorporation of Kelley Company, Inc. is hereby amended to provide that "The name of the corporation is SPX Dock Products, Inc. (the "Corporation")."

Section 1.1 Name. The name of the corporation is SPX Dock Products, Inc. (the "Corporation").
