ARTICLES OF INCORPORATION  
OF  
KELLEY COMPANY, INC.

The following Restated Articles of Incorporation duly adopted pursuant to the authority and provisions of the Wisconsin Business Corporation Law, Chapter 180 of the Wisconsin Statutes (the "WBCL") supersede and take the place of the existing articles of incorporation of Kelley Company, Inc. (the "Corporation") and any amendments thereto:

1. The present name of the Corporation is Kelley Company, Inc.
2. Article 1, Section 1 of the articles of incorporation of Kelley Company, Inc. is hereby amended to provide that "The name of the corporation is SPX Dock Products, Inc. (the "Corporation")." OK Pw  
Jan 2007
3. The provisions of the articles of incorporation of Kelley Company, Inc. as herein amended are hereby restated and integrated into the single instrument which is hereinafter set forth, and which is entitled "Restated Articles of Incorporation of SPX Dock Products, Inc."
4. These Restated Articles of Incorporation contain an amendment that required shareholder approval.
5. The undersigned officer of SPX Dock Products, Inc. hereby certifies that the foregoing Restated Articles of Incorporation of the Corporation were duly adopted by the Board of Directors of the corporation on January 13, 2004 and by the sole shareholder of the Corporation as of January 13, 2004, in accordance with section 180.1003 of the WBCL.
6. The articles of incorporation of the Corporation, as amended and restated herein, shall upon the filing of this Restated Articles of Incorporation of Kelley Company, Inc. read, in their entirety, as follows:

ARTICLE I.Name

Section 1.1 Name. The name of the corporation is SPX Dock Products, Inc. (the "Corporation").

ARTICLE II.Purposes

Section 2.1 Purposes. The purpose for which the Corporation is organized is to engage in any lawful activity within the purposes for which corporations may be organized under the WBCL.

ARTICLE III.Capital Stock

Section 3.1 Number of Shares and Classes. The aggregate number of shares which the Corporation shall have authority to issue is thirty-seven thousand five hundred (37,500) shares consisting of one class only, designated as "Common Stock" without par value.

ARTICLE IV.Pre-Emptive Rights

Section 4.1 Pre-Emptive Rights. The holders of common shares shall not be entitled to any pre-emptive rights.

ARTICLE V.Registered Office and Agent

Section 5.1 Registered Office and Agent. The address of the registered office of the corporation is 8025 Excelsior Drive #200, Madison, Wisconsin 53717, and the name of the registered agent of the corporation at such address is:

ARTICLE VI.Directors

Section 6.1 Number of Directors. The number of directors shall be fixed by, or in the manner provided in, the bylaws.


ARTICLE VII.Amendments
