I hereby authorize and request the Patent Office of the United States and any and all foreign countries to issue any and all of said patents, when granted to Assignee as the Assignee of our entire right, title and interest in and to the same, for the sole use and enjoyment of Assignee, its successors, and assigns

Further, I agree that I will communicate to Assignee, or its representatives, any facts known to us respecting said inventions, and testify in any legal proceedings, sign all lawful papers, execute all non-provisional patent applications, divisions, continuations, substitutions, renewals, and reissue applications, execute all necessary papers to cause any and all of said patents to be issued to Assignee, make all rightful oaths and generally do everything necessary or desirable to aid Assignee, its successors and assigns, to obtain and enforce proper protection for said inventions in the United States and in any and all foreign countries.

The undersigned further declares that all statements made herein of his own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements and the like so made are punishable by fine or imprisonment, or

both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issued thereon.

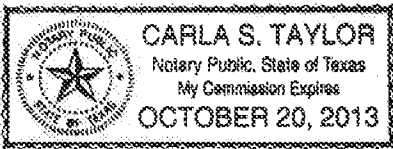
