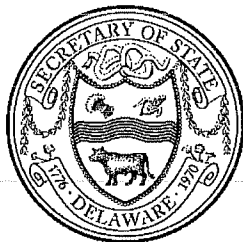

Opel Inc., a corporation organized and existing under the laws of the State of Delaware (the "Corporation"), pursuant to Section 242 of the Delaware General Corporation Law, hereby certifies as follows:

1. The Board of Directors of the Corporation duly adopted the following resolutions in accordance with the provisions of Sections 141 and 242 of the Delaware General Corporation Law:

RESOLVED: That it is hereby declared advisable that ARTICLE FIRST of the Third Amended and Restated Certificate of Incorporation of the Corporation be amended by amending such article to read as follows:

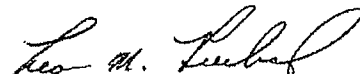
"FIRST. The name of the Corporation is Opel Solar, Inc."
