WHEREAS, the assignor is a co-inventor for **VERTEBRAL INTERBODY SPACER** for which an application for United States Letters Patent has been filed in the United States Patent and Trademark Office, Application Serial No. 13/182,942, filed July 14, 2011;

WHEREAS the assignor has been employed by **Wake Forest University Health Sciences**, an educational institution having a principal place of business at Medical Center Boulevard, City of Winston-Salem, County of Forsyth, State of North Carolina 27157, hereinafter referred to as assignee, and has, in consideration thereof, agreed to assign any and all inventions arising from his employment to assignee including that in the above identified application;

in all foreign countries in accordance with the International Convention, the same to be held and enjoyed by said assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by assignors if this assignment and sale had not been made..

The assignor further covenants and agree to bind his heirs, legal representatives, and assigns promptly to communicate to said assignee or its representatives any facts known to him relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional papers which may be requested to confirm the right of the assignee, its representatives, successors, or assigns to secure patent or similar protection for the said invention in all countries and to vest in the assignee complete title to the said invention and Letters Patent, without further compensation, but at the expense of said assignee, its successors, assigns, and other legal representatives.

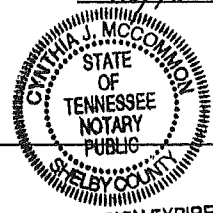
