### ASSIGNMENT OF PATENT APPLICATIONS BY INVENTORS

We, undersigned inventors Daniel Gorman and Kemper Barkhurst (hereafter "INVENTORS"), have invented certain new and useful and ornamental improvements as set forth in the U.S. Patent Applications entitled SECURITY ENCLOSURE FOR TABLET DISPLAY DEVICES and DISPLAY TABLET ENCLOSURE, which bear U.S. application nos. 13/212,770 and 29/399,786, respectively, both filed August 18, 2011 (hereafter "Applications").

(b) Authorize and request the Commissioner of Patents to issue any and all United States Patents resulting from the Applications or any division, continuation, continuation-in-part, substitute, renewal, reexamination or reissue or extension thereof to ASSIGNEE.

(c) Agree to execute all papers and documents and, entirely at ASSIGNEE's expense, to communicate to ASSIGNEE any facts known to us respecting the inventions and discoveries, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, execute all papers deemed by ASSIGNEE to be necessary for recording this Assignment, including any Confirmatory Assignments, with the United States Patent and Trademark Office and any foreign patent offices, and generally perform any and all acts which are reasonably necessary and/or which said ASSIGNEE, its

successors, assigns or other legal representatives may deem necessary to secure thereto the rights herein assigned, sold and transferred.

(d) Warrant and covenant that no other assignment, license, contract, understanding, interest or other grant to any third party with respect to any of the foregoing has been made, or shall in the future be made, by or on behalf of INVENTORS.

(e) Covenant not to challenge the validity or enforceability of any of the patent applications or patents assigned to ASSIGNEE hereunder.

(f) Agree that the terms, covenants and conditions of this assignment shall inure to the benefit of ASSIGNEE, its successors, assigns and other legal representatives, and shall be binding upon INVENTORS, as well as upon INVENTORS' heirs, legal representatives and assigns.

(g) Authorize and request our attorney/agent to insert the application number in the space above in order to assist with recordation of this assignment and/or to insert any other information necessary to perfect this assignment, if necessary.

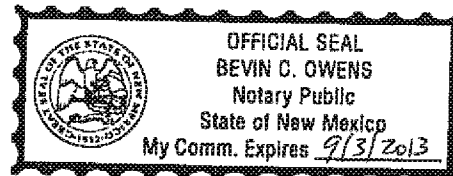
