ASSIGNMENT

WHEREAS, I, José FORNES, residing at 32 rue de Richelieu, 86200 Loudun, FRANCE, made certain new and useful inventions and improvements for which I executed an application for Letters Patent of the United States, which is entitled HEAD GATE ELEMENT COMPRISING A SOLID CONTROL BAR PROVIDED WITH A NOTCH FOR LOCKING THE MOVABLE BAR, which issued as U.S. Patent No. 6,615,768 on September 9, 2003;

NOW, THEREFORE, to all whom it may concern, be it known that for and in consideration of the sum of One Dollar and other good and valuable considerations, the receipt and sufficiency whereof is hereby acknowledged, I have sold, assigned and transferred, and by these presents do sell, assign and transfer unto said Agritubel SA, its successors or assigns, the entire right, title and interest in and to all inventions and improvements disclosed in the aforesaid application, and in and to all Letters Patent granted therefrom, including U.S. Patent No. 6,615,768 and all reissues or extensions of such patents, and in and to any applications which were filed in any foreign countries for Letters Patent on the said inventions and improvements, and all Letters Patent of foreign countries which may be granted therefrom;

AND, for the consideration aforesaid, I do hereby agree that I and my executors and legal representatives will make, execute and deliver any and all other instruments in writing including any other documents, and will communicate to said Agritubel SA, its successors and representatives all facts known to them relating to said improvements and the history thereof and will testify in all legal proceedings and generally do all things which may be necessary or desirable to more effectually secure to and vest in Agritubel SA, its successors or assigns the entire right, title and interest in and to the said improvements, inventions, applications, Letters Patent, rights, titles, benefits, privileges and advantages hereby sold, assigned and conveyed, or intended so to be.

AND, furthermore, I, José FORNES, covenant and agree with said Agritubel SA, its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by me and that full right to convey the same as herein expressed is possessed by me.

The parties hereto acknowledge that they have specifically requested the present agreement to be drawn up in the English language.
