WORLDWIDE ASSIGNMENT

WHEREAS Milos R. POPOVIC, Massimo TARULLI, Aleksandar PRODIC, and Peter LEHN (hereinafter referred to as 'INVENTORS'), whose full post office addresses are respectively: 2919 Crosscurrent Dr., Mississauga, Ontario, L5N 6K9, CANADA; 43 Edenvale Cres. Toronto, Ontario M9A 4A5 CANADA; 2 Withrow Avenue, Unit 19, Toronto, Ontario M4K 1C9 CANADA; and 155 Hillhurst Blvd. Toronto, Ontario M5N 1N7 CANADA, made one or more Inventions (the "Inventions"), as described in the specification entitled FUNCTIONAL ELECTRICAL STIMULATION DEVICE AND USE THEREOF filed with the United States Patent and Trademark Office on June 4, 2010 under serial number 61/351,715 (hereinafter referred to as the United States Provisional Patent Application), and as further described in the specification entitled FUNCTIONAL ELECTRICAL STIMULATION DEVICE AND SYSTEM, AND USE THEREOF filed with the Canadian Receiving Office of the World Intellectual Property Organisation on June 2, 2011 under serial number PCT/CA2011/000637 (hereinafter referred to as the International Application), which claims priority from the United States Provisional Application;

WHEREAS the INVENTORS have, by an assignment made May 3, 2011, assigned to TORONTO REHABILITATION INSTITUTE, their entire right, title and interest in, to and under the Inventions throughout the world;

WHEREAS THE UNIVERSITY OF TORONTO (hereinafter referred to as 'ASSIGNOR'), whose full post office address is 27 King's College Circle, University of Toronto, Toronto, Ontario M5S 1A1 CANADA, asserts that, pursuant to an Inventions Policy adopted by the ASSIGNOR and assented to by the INVENTORS, all rights in the Inventions shall be jointly owned by the ASSIGNOR and the INVENTORS and, as a result of such joint ownership, the ASSIGNOR enjoys a right to exploit the Inventions through the activities of the ASSIGNOR, in such a manner as may be co-extensive with, and equal to, the rights of the INVENTORS, or their assignee, TORONTO REHABILITATION INSTITUTE, to exploit the Inventions;

WHEREAS TORONTO REHABILITATION INSTITUTE is a University of Toronto Teaching and Research Hospital, and the UNIVERSITY OF TORONTO, the ASSIGNOR herein, and TORONTO REHABILITATION INSTITUTE have entered into an Affiliation Agreement; and

WHEREAS the ASSIGNOR has determined that it shall assign all of its right, title and interest as a joint owner of the Inventions, to the INVENTORS;

NOW THEREFORE, to all whom it may concern be it known that for and in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the ASSIGNOR hereby confirms that it has sold, assigned and transferred to the INVENTORS, their successors and assigns, its entire right, title and interest in and to the Inventions for all countries worldwide, and in and to the United States Provisional Patent Application and its corresponding right to claim priority therefrom, and in and to the International Application and its corresponding right to claim priority therefrom, and in and to any and all corresponding patent applications filed worldwide for the Inventions, including, but not limited to, any and all divisions, continuations, continuations-in-part and extensions thereof, and in and to any and all patents that may be obtained therefor worldwide, including, but not limited to, any and all reissues, renewals, and prolongations thereof, for the sole use and benefit of the INVENTORS, their successors and assigns, to the full end of the term or terms of any and all such patents when granted, including any and all renewals, reissues, and prolongations thereof, as fully and entirely as the same would have been held and enjoyed by the ASSIGNOR had this Assignment not been made.

The ASSIGNOR hereby undertakes without liability at any time upon request to do everything legally possible to assist the INVENTORS in the filing and prosecution of any patent application relating to the Inventions in any country, to sign such documents and do such things as may be required to give effective legal and registered title of the Inventions to the INVENTORS in any country, all without further consideration but at the expense of the INVENTORS;

AND the ASSIGNOR hereby authorizes and requests the Director of the U.S. Patent and Trademark Office to issue United States Letters Patent for the Inventions to the INVENTORS for their sole use and benefit, and for the use and benefit of their successors and assigns, to the full end of the term for which said United States Letters Patent may be granted, as fully and entirely as the same would have been held by the ASSIGNOR had this assignment and sale not been made.

The undersigned hereby grant to the firm of Gastle and Associates, whose full mailing address is 12 Bridge Street Suite 202, P.O. Box 430, Lakefield, Ontario, Canada, K0L 2H0, the power to insert on this assignment any further information pertaining to the referenced patents, patent applications, industrial designs, and industrial design applications, which may be necessary to permit the respective Patent Offices to record this assignment.

This Assignment shall inure to the benefit of, and be binding upon, the ASSIGNOR, and the INVENTORS, and their respective heirs, executors, legal personal representatives, successors and assigns.

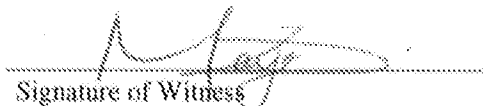
