ASSIGNMENT OF PATENT RIGHTS

This Agreement is by and between

Assignor hereby authorizes and requests the Director of the United States Patent and Trademark Office, and the patent office or agency of all foreign countries and multinational organizations, to issue any and all patents on said inventions to the Assignee as the owner of the entire interest, for the sole use and benefit of the said Assignee, its successors, assigns and legal representatives, for the full term or terms for which the same may be granted.

Assignor hereby agrees and represents, without further consideration and without expense to Assignor, that its representatives and the inventors are obligated to sign all lawful papers and perform all other lawful acts which the Assignee may request to make this Assignment fully effective, including, by way of example but not of limitation:

Prompt execution of all original, divisional, continuation, continuation-in-part, reissue, substitute, and other United States and foreign patent applications on said inventions, and all lawful documents

requested by the Assignee to further the prosecution of any of such patent applications.

Cooperation in the execution of all lawful documents, the production of evidence, nullification, reissue, extension, or infringement proceedings involving said inventions.
