ASSIGNMENT

WHEREAS, **Kunio SUZUKI**, a citizen of JAPAN, whose post office address is 1238-8, Gomigaya, Tsurugashima-shi, Saitama, 350-2202, JAPAN (hereinafter "ASSIGNOR") is the owner of the entire right, title and interest in and to

and the inventions disclosed therein and any and all divisions and continuations thereof, and any and all Letters Patent which may be granted thereon, including any and all renewals, extensions, reissues, reexaminations, and prolongations thereof (hereinafter collectively "Patent Rights"), by means of the following: (i) assignment recorded on March 17, 2011, Reel 025974, Frame, 0362; (ii) assignment recorded on November 5, 1998 at Reel 009578, Frame 0956; (iii) assignment recorded on July 2, 2000 at Reel 010953, Frame 0582, and (iv) Change of Name recorded on August 7, 2002 at Reel 013169, Frame 0521, of the U.S. Patent and Trademark Office assignment records.

AND WHEREAS, **TOYO HAKKO CO., LTD.** a corporation organized and existing under the laws of JAPAN, whose post-office address is 39-1, Yoshikawa-cho 1-chome, Obu-shi, Aichi, 474-0046, JAPAN, hereinafter known as the ASSIGNEE, is desirous of acquiring a twenty percent (20%) undivided interest in the Patent Rights for the United States from ASSIGNOR, such that ASSIGNEE and ASSIGNOR shall be joint owners of the Patent Rights, with ASSIGNEE owning a twenty percent (20%) undivided ownership interest in and to the Patent Rights in the United States and ASSIGNOR retaining and continuing to own an undivided eighty percent (80%) ownership interest in and to the Patent Rights in the United States, and the entire right, title and interest in and to any Patent Rights foreign to the United States.

NOW, THIS WITNESSETH that for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt whereof is hereby acknowledged, said ASSIGNOR hereby assigns, sells and transfers to said ASSIGNEE, its assigns and legal representatives, an undivided twenty percent (20%) ownership interest in and to the Patent Rights, as that term is defined above, in the United States, and all rights to sue for past and future infringement thereunder, said ASSIGNEE and its assigns and legal representatives to have, hold, exercise and enjoy the twenty (20%) ownership interest in said Letters Patent, with all the rights, powers, privileges, and advantages in any ways arising from or pertaining thereto, for and during the term or terms of any and all such Letters Patent when granted, including any and all renewals, reissues, reexaminations, and prolongations thereof, for the use and benefit of said ASSIGNEE and its assigns and legal representatives in as ample and beneficial a manner to all intents and purposes as the said ASSIGNOR might or could have held and enjoyed the same, if this assignment had not been made.

AND said ASSIGNOR hereby agrees, without further remuneration, to execute all papers necessary to file applications in the United States for said Letters Patent and to assign the same undivided twenty-percent (20%) ownership interest in and to the Patent Rights in the United States

to said ASSIGNEE;

AND said ASSIGNEE hereby agrees and represents that ASSIGNEE will not assign, sell or otherwise pledge as security, its undivided twenty percent (20%) in and to the Patent Rights in the United States without the written consent of joint owner ASSIGNOR;

AND said ASSIGNOR authorizes and requests the Commissioner of Patents to issue Letters Patent, and any and all divisions and continuations thereof, jointly to said ASSIGNOR and to said ASSIGNEE, their assigns and legal representatives, in accordance herewith.
