AND I hereby authorize and request the Commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States whose duty it is to issue patents on patents as aforesaid, to issue to said assignee, as assignee of the entire right, title and interest, said Letters Patent of the United States, in accordance with the terms of this assignment.
