**ASSIGNMENT**

FURTHER I hereby authorize and request any official of any state, responsible for issuing patents or other evidence or forms of any industrial property protection, to issue the same for the invention to the Company, its successors, legal representatives and assigns, in accordance with this assignment.

ALSO I hereby agree that I have the full right to convey my entire, right, title and interest in and to the invention world-wide and all applications for industrial property protection for the invention world-wide and that I have not executed, and will not execute, any agreement in conflict with this assignment.

MOREOVER I hereby agree that I will communicate to the Company, its successors, legal representatives and assigns any facts known to me respecting the invention and testify in any legal proceeding, sign any lawful papers, execute any original, divisional, continuation and reissue applications, make any rightful oaths, and generally do everything possible to aid the Company, its successors, legal representatives and assigns to obtain and enforce proper protection for the invention world-wide.
