ASSIGNMENT

WHEREAS, We, Daniel Rasenberg, residing at Ericssonstraat 17, 5121 MK Rijen, Netherlands; and Martin Staps, residing at Pastoor van Herdegomstraat 23, 2387 Baarle-Hertog, Belgium; have invented certain new and useful improvements in Seat and Settee for which We: have filed an application for Letters Patent of the United States on October 25, 2012 under Serial No.29/435550; and

WHEREAS, Jardin Netherlands B.V. organized under the laws of the Netherlands, is desirous of obtaining the entire right, title, and interest in, to and under the said improvements and the said application;

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, we have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto Jardin Netherlands B.V., its successors, legal representatives, and assigns the entire right, title, and interest in, to and under the improvements, and the application and all divisions, renewals, and continuations thereof, and all Letters Patents of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for said improvements in any country or countries foreign to the United States, and all Letters Patents which may be granted for said improvements in any country or countries foreign to the United States and all extensions, renewals, and reissues thereof; and we hereby authorize and request the Commissioner of Patents of the United States and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvement to Jardin Netherlands B.V., its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY covenant that WE have full right to convey the entire interest herein assigned, and that WE have not executed, and will not execute, any agreement in conflict herewith.


AND WE HEREBY further covenant and agree that WE will communicate to Jardin

Netherlands B.V., its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid Jardin Netherlands B.V. its successors, legal representatives and assigns to obtain and enforce proper patent protection for said improvements in all countries.

AND WE HEREBY further assign and transfer to Jardin Netherlands B.V. all priority rights derived from such application therefore by virtue of the International Convention for the Protection of Industrial Property for any and all member countries of the aforesaid International convention and WE do hereby assign and transfer to Jardin Netherlands B.V. the sole right to file further applications for patents under the patent laws of any country of the world based on any improvements disclosed in said application as fully and entirely as the same would have been held by us had this assignment not been made.
