Assignor hereby agrees that, when requested, I shall, without charge to Assignee but at its expense, sign all papers, and do all acts which may be necessary, desirable or convenient in connection with said applications, patents, or other forms of protection.

Assignor hereby agrees that, I will communicate to said Assignee or its representatives any facts known to me respecting said inventions and, when requested by said Assignee and at its expense, will testify in any legal proceedings, and generally do everything possible to aid said Assignee, its successors, assigns, and legal representatives or nominees, to obtain or enforce proper protection for said inventions in any and all countries.




