*(Pursuant to Section 253 of the Delaware General Corporation Law (the "GCL"))*

Cytec Surface Specialties Inc., a corporation organized and existing under the laws of the State of Delaware ("CSS"), **DOES HEREBY CERTIFY:**

**FIRST:** CSS was incorporated on the 28<sup>th</sup> day of January, 1997, pursuant to the GCL.

**SECOND:** CSS owns one hundred percent (100%) of the outstanding capital stock of Surf Chip, Inc., a corporation incorporated on the 2<sup>nd</sup> day of October, 1998, pursuant to the GCL ("Surf").

**THIRD:** CSS, by the following resolutions of its Board of Directors, duly adopted by the unanimous written consent of the members thereof, filed with the minutes of the Board, pursuant to the GCL on December 15, 2005, determined to, and upon the filing of this Certificate of Ownership and Merger with the Secretary of State of the State of Delaware, does hereby merge Surf into CSS effective as of 3:00PM on December 31, 2005:

**WHEREAS,** CSS is the legal and beneficial owner of one hundred percent (100%) of the outstanding capital stock of Surf; and

**WHEREAS,** Surf desires to merge itself into CSS pursuant to the provisions of Section 253 of the GCL;

**NOW, THEREFORE, BE IT RESOLVED,** that effective upon the filing of an appropriate Certificate of Ownership and Merger embodying these resolutions with the Secretary of State of Delaware, CSS merges into itself Surf and assumes all of the obligations and liabilities of Surf; and it is further

**RESOLVED**, that the President or any Vice President of CSS be and each of them hereby is authorized to make and execute, and the Secretary of CSS or any Assistant Secretary be and each hereby is authorized to attest, a Certificate of Ownership and Merger setting forth a copy of these resolutions providing for the merger of Surf into CSS, and to cause the same to be filed with the Secretary of State of Delaware and do all acts and things, whatsoever, whether within or without the State of Delaware, which may be in any way necessary or appropriate to effect said merger; and it is further

**RESOLVED**, that the officers of CSS be, and each of them hereby is, authorized and empowered, on behalf of CSS and in its name, to take all actions and do all things necessary or desirable, and to execute and deliver all documents, agreements and certificates necessary to carry out the purposes of each of the foregoing resolutions.


