ASSIGNMENT

Docket No. BBC-019/B); and United States Application Ser. No. 10/307356, filed 22 November 2002 (Atty. Docket No. BBC-019/B1) all entitled: "HUMAN ANTIODIES THAT BIND TO HUMAN TNF α "; including any renewals, revivals, reissues, reexaminations, extensions, continuations and divisions thereof, and any substitute applications therefor;

We further agree at any time to execute and to deliver upon request Abbott Biotechnology Ltd., such additional documents, if any, as are necessary or desirable to secure patent protection on said inventions, discoveries and applications throughout all countries of the world, and otherwise to do the necessary to give full effect to and to perfect the rights of Abbott Biotechnology Ltd. under this Assignment, including the execution, delivery and procurement of any and all further documents evidencing this assignment, transfer and sale as may be necessary or desirable.
