(f) except for obligations and/or rights to royalties and other payments owed or to be made to GPH pursuant to agreements existing as of and prior to the Assignment Date, all rights

to collect royalties and other payments under or on account of any of the Assigned Patents and/or any item in the foregoing categories (a) through (e).

The foregoing assignment (and any subsequent assignment of the Assigned Patent Rights) will be subject to all licenses, covenants not to sue and other rights granted under the Assigned Patent Rights prior to and as of the Assignment Date.




