ASSIGNMENT

WHEREAS, Carlos Chover Lopez, Lluís Hierro Domenech, and Emilio Angulo Navarro are inventors of an invention subject to United States Patent Application Serial No. 13/718747 filed December 18, 2012 and entitled "INTERCHANGEABLE PRINTER PLATENS"


