ASSIGNMENT

Assign, transfer, and convey to Assignee the Assignor's entire right, title, and interest in and to said designs, inventions and discoveries, said application for Letters Patent, any and all other applications for Letters Patent on said designs, inventions and discoveries in whatsoever countries, including all divisional, renewal, substitute, continuation, continuation-in-part, and convention applications based in whole, or in part, upon said designs, inventions or discoveries, or upon said applications, and any and all Letters Patents, reissues, and extensions of Letters Patent granted for said designs, inventions and discoveries or upon said applications, and every priority right that is or may be predicated upon, or arise from said designs, said inventions, said discoveries, said applications, and said Letters Patent;

Authorize Assignee to file design patent applications in any or all countries on any or all of said designs, inventions and discoveries in my name or in the name of Assignee or otherwise as Assignee may deem advisable, under International Conventions or otherwise;

Authorize and request the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments throughout the world to issue or transfer all said Letters Patents to Assignee or otherwise as Assignee may direct;

Warrant that the Assignor has not knowingly conveyed to others any right in said designs, inventions, discoveries, applications, or patents, or any license to use the same, or to make, use, or sell anything embodying or utilizing any of said designs, inventions or discoveries; and that Assignor has good right to assign the same to Assignee without encumbrance;

Bind Assignor and Assignor's heirs and legal representatives, without further consideration, to cooperate with Assignee in the prosecution of said application for Letters Patent and any and all other applications for Letters Patent on said designs, inventions and discoveries, execute, verify, acknowledge and deliver all such further papers, including any and all other applications for Letters Patent on said designs, inventions and discoveries, and instruments of assignment and transfer thereof, and will communicate any facts known to Assignors relating to the designs, inventions and discoveries, to obtain or maintain or enforce said Letters Patent for the designs, inventions and discoveries and improvements therein in any and all countries and to vest title thereto in Assignee. Assignors further agrees that such Assignors will, without further compensation to Assignors during the term of such Assignors' employment by Assignee and thereafter for reasonable compensation as determined by Assignee, perform such other acts as may be reasonably required when requested by Assignee, including attending depositions, preparing and executing declarations and affidavits and testifying as a witness, to obtain or maintain or enforce said Letters Patent for the designs, inventions and discoveries and improvements therein in any and all countries and to vest title thereto in Assignee.
