RELEASE OF CERTAIN INTELLECTUAL PROPERTY

THIS RELEASE OF CERTAIN INTELLECTUAL PROPERTY (this "Release") is made as of November 8, 2012 (the "Effective Date") by Wilmington Trust, National Association, not in its individual capacity, but solely as collateral agent (in such capacity, the "Collateral Agent"), in favor of KINETIC CONCEPTS, INC., a Texas corporation (the "Lead Borrower"), KCI USA, INC., a Delaware corporation ("KCI USA" and, together with the Lead Borrower, the "Co-Borrowers") and each of the grantor parties identified on the signature page hereto (each, together with the Borrower, the "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Second Lien Security Agreement, dated as of November 4, 2011, between the grantors party thereto, the Collateral Agent and Wilmington Trust, National Association, as trustee (the "Trustee"), and the Second Lien Intellectual Property Security Agreement between the grantors party thereto, the Collateral Agent and Trustee, dated as of November 4, 2011 (the "IP Security Agreement"), each of the Grantors pledged, assigned and granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to certain collateral including, without limitation, (a) all trademarks, service marks, trade names, domain names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now owned or hereafter used, adopted or acquired, and all registrations and applications filed in connection therewith, and all extensions or renewal thereof, with respect to the foregoing, as they relate to the Business (as that term is defined in Annex 1 of this Release), including, without limitation, the trademark registrations and applications set forth on Schedule I hereto, along with the goodwill associated therewith (all of the foregoing collectively, the "Trademarks"), (b) all of the following now owned or hereafter acquired by any of the Grantors: (i) all letters patent of the United States or the equivalent thereof in any other country, all registrations thereof, and all applications for letters patent of the United States or the equivalent thereof in any other country, including registrations and pending applications in the United States Patent and Trademark Office or any similar offices in any other country, with respect to the foregoing, as they relate to the Business, and (ii) all reissues, continuations, divisions, continuations-in-part, renewals or extensions thereof, and the inventions disclosed or claimed therein, including the right to make, use and/or sell the inventions disclosed or claimed therein, including, without limitation, the patents and patent applications set forth on Schedule II hereto (all of the foregoing collectively, the "Patents"); (c) all of the following now owned or hereafter acquired by any of the Grantors: (i) all copyright rights in any work subject to the copyright laws of the United States or any other country, whether as author, assignee, transferee or otherwise, and (ii) registrations and applications for registration of any such copyright in the United States or any other country, with respect to each of the foregoing, as they relate to the Business, including, without limitation, the copyright registrations set forth in Schedule III hereto and exclusive copyright licenses (all of the foregoing collectively, the "Copyrights"); (d) all Licenses (as that term is defined in Annex 1 of this Release); (e) all other Intellectual Property (as that term is defined in Annex 1 of this Release); and (f) to the extent not otherwise included, proceeds and products of any and all of the foregoing and all supporting obligations, collateral security and guarantees given by any person with respect to any of the foregoing, with respect to each of the foregoing, only to the extent related to the Business ;

WHEREAS, in connection with the IP Security Agreement, Grantor and Collateral Agent entered into a Second Lien Short Form Intellectual Property Security Agreement dated November 4, 2011 concurrent with entering into the IP Security Agreement, for the purposes of recording the security interests granted in the IP Security Agreement (the "Short Form IP Security Agreement");

WHEREAS, the Short Form IP Security Agreement was recorded with the Trademark Division of the U.S. Patent & Trademark Office on November 8, 2011, at Reel 4682 and Frame 0183;

WHEREAS, the Short Form IP Security Agreement was recorded with the Patents Division of the U.S. Patent & Trademark Office on November 8, 2011, at Reel 027194 and Frame 0447;

WHEREAS, the Short Form IP Security Agreement was recorded with U.S. Copyright Office on November 8, 2011, at Volume 3601 and Document 190;

WHEREAS, pursuant to Section 5.1 of that certain Intercreditor Agreement, dated as of November 4, 2011, by and among Bank of America, N.A., as first-lien collateral agent (the "First Lien Agent"), the Collateral Agent and Trustee, the Collateral Agent has agreed to deliver such instruments, releases or termination statements reflecting the release of its security interests in the Trademarks, Patents and Copyrights upon receipt of a notice (the "First Lien Release Notice") from the First Lien Agent stating that the release of the First Lien Agent's security interests in such Trademarks, Patents and Copyrights is effective;

WHEREAS, the Collateral Agent has received the First Lien Release Notice;

NOW, THEREFORE, in connection with the sale of all of the Trademarks, Patents, Copyrights, other Intellectual Property, Licenses and other rights referenced in the first WHEREAS above of this Release pursuant to that certain Asset Purchase Agreement, dated as of August 14, 2012, by and between the Lead Borrower and Getinge AB, the Collateral Agent hereby terminates, cancels, re-pledges, reassigns and releases (a) any and all security interests it has against only the Trademarks, the Patents, the Copyrights, other Intellectual Property, Licenses and other rights referenced in the first WHEREAS above of this Release; and (b) any and all licenses granted in the IP Security Agreement as it relates to any of the foregoing rights. For the avoidance of doubt the only security interests being released by the Collateral Agent pursuant to this Release are those to the Trademarks, Patents, Copyrights, other Intellectual Property, Licenses and other rights referenced in the first WHEREAS above of this Release. The remainder of the security interests granted pursuant to the IP Security Agreement shall remain in effect in all respects.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademarks, the Patents, the Copyrights other Intellectual Property, Licenses or other rights referenced in the first WHEREAS above of this Release, it hereby re-assigns and re-transfers such rights, title or interest to their respective Grantors.

The Collateral Agent hereby agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance

(including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

"License" shall mean any Patent License, Trademark License, Copyright License or other Intellectual Property license or sublicense agreement to which any Grantor is a party.

"Patent License" shall mean any written agreement, now or hereafter in effect, granting to any third party any right to make, use or sell any invention on which a Patent, now owned or hereafter acquired by any Grantor or that any Grantor otherwise has the right to license, or granting to any Grantor any right to make, use or sell any invention on which a Patent, now owned or hereafter acquired by any third party, and all rights of any Grantor under any such agreement.

"Trademark License" shall mean any written agreement, now or hereafter in effect, granting to any third party any right to use any Trademark now owned or hereafter acquired by any Grantor or that any Grantor otherwise has the right to license, or granting to any Grantor any right to use any Trademark, now owned or hereafter acquired by any third party, and all rights of any Grantor under any such agreement.
