ASSIGNMENT OF RIGHTS IN INVENTION

WHEREAS, we, Robert W. Lewis, having an address at 9811 Warwick Circle, Charlotte, NC 28210, and Timothy A. Barrett having an address at 36 Wahl Street, Douglassville, PA 19518 have invented certain new and useful improvements in a WASTE TREATMENT APPARATUS AND METHOD (hereinafter referred to as the "Invention") for which we filed U.S. Patent Application Serial No. 11/431,260 on May 10, 2006 and U.S. Divisional Patent Application Serial No. 13/065,154 on March 15, 2011; and

I hereby assign, sell, and transfer, effective as of May 10, 2006 a 100% undivided interest in said Invention, said applications, including any divisions, continuations, and continuations-in-part thereof, and in and to any and all Letters Patent of the United States, including U.S. Patent Nos. 7,931,860 and 8,318,104, and countries foreign thereto, which may be granted for said Invention, and in and to any and all priority rights, Convention rights, and other benefits accruing or to accrue to us with respect to the filing of applications for patents or securing of patents in the United States and countries foreign thereto, unto said Assignee;

And hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said Assignee, as assignee of the whole right, title, and interest thereto;

And we further agree to execute all necessary and lawful future documents, including assignments in favor of Assignee, or its designees as Assignee or its assignees may from time-to-time present to us in order to perfect title in said Invention, modifications, and improvements in said Invention, applications and Letters Patent of the United States and countries foreign thereto;

And we further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing divisions, continuations and continuations-in-part of said application for patent, and/or, for obtaining any reissue or reissues of any Letters Patent


which may be granted for our aforesaid Invention, as the Assignee thereof shall hereafter require and prepare at its own expense.
