
For good and valuable consideration, the receipt and adequacy of which is acknowledged, Assignor hereby:



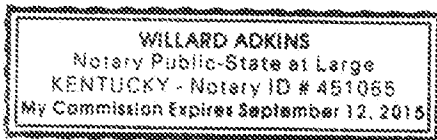
