ASSIGNMENT OF PATENT APPLICATION

WHEREAS, WE, **Ulrich Speck**, a citizen of **GERMANY**; and **Madeleine C. Berg**, a citizen of **GERMANY** (hereinafter referred to as "ASSIGNORS"), have invented and own a certain invention entitled **COATING FORMULATIONS FOR SCORING OR CUTTING BALLOON CATHETERS** for which application for Letters Patent of the United States of America was filed on **SEPTEMBER 27, 2012**, and assigned Serial No. **13/628,627**; and

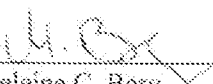
said Letters Patent or any legal equivalent thereof to said ASSIGNEES, their successors and assigns, in accordance with this Assignment.
